The authorised person shall supervise the proper functioning of the manufacturer's production management system at least once every 12 months, shall carry out tests on product samples and assess whether the product's characteristics comply with the construction technical certificate in accordance with the provisions of Section 5(4) of the above-mentioned Government Order. The authorised person shall issue a report on the evaluation of the surveillance, which shall be forwarded to the manufacturer.
